Tri-County YMCA Dodgeball Roster Waiver and Release of Liability

In consideration of being allowed to participate in events hosted by the Tri-County YMCA

- 1) Agree that prior to participating, they will inspect the facilities to be used, and if they believe anything is unsafe they will advise the supervisor of such condition (s) and refuse to participate;
- 2) Acknowledge and fully understand that each participant will engage in activities that involve risk of serious injury including permanent disability or death, and severe social and economic losses which might result not only from their own actions, inaction's, or negligence of others, the rules of play, or the conditions of the premises or of any equipment used. Further that there may be other risks not known to us or not reasonably foreseeable at this time.
- 3) Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
- 4) Release, waive, discharge, and covenant not to sue the Tri-County YMCA, their respective administrators, directors, agents, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of the premises used to conduct the event, all of which are hereafter referred to as "released" from any and all liability to each of the undersigned, his or hers heirs and next of kin for ant and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the release or otherwise.
